1.2 Who we are

MAG is a registered Australian company and a wholly owned subsidiary in the Aurecon group of companies.

MAG provides expert advice on carbon and environmental markets in Australia and assists its customers to develop carbon market strategies. MAG provides resources, knowledge, guidance and support for customers wishing to participate in the carbon market, including through:

- monthly newsletters and other market commentary; and
- bespoke customer engagements and reports (these services are only provided to customers who are wholesale clients).

1.3 The financial services we provide

Some of the services which MAG provides are financial services within the meaning of the Corporations Act 2001 (Cth) (**Corporations Act**). For example, to the extent that MAG makes recommendations or statements of opinion in relation to carbon credit units or emission units in its newsletters or in its bespoke engagements or reports for customers, such recommendations or statements of opinion may constitute financial product advice.

To the extent that MAG provides financial services, it does so as an authorised representative of the Licensee.

MAG is authorised by the Licensee to provide financial product advice to retail and wholesale clients in relation to derivatives, Australian Carbon Credit Units (**ACCUs**) and eligible international emissions units (**EIEUs**).

MAG is also authorised by the Licensee to provide the following financial services to wholesale clients:





- Deal in a financial product by issuing, applying for, acquiring, varying or disposing of a financial product in respect of certain derivatives; and
- Deal in a financial product by applying for, acquiring, varying or disposing of a financial product on behalf of another person in respect of derivatives, ACCUs and EIEUs.

Generally, when we provide financial services we act on our own behalf. However, we may act on behalf of others when we deal in a financial product when arranging for a client to apply for, acquire, vary or dispose of an interest in ACCUs and/or derivatives.

1.4 For retail clients, any advice we give is general advice only

All information and commentary we provide to retail clients, for example in our newsletter, is of a general nature only and does not take into account your objectives, financial situation or needs. That means, to the extent that the information or commentary contains financial product advice, it is general advice only.

Before deciding to do anything based on the information you receive from us, you should have regard to your own circumstances and consider your own objectives, financial situation or needs and consider seeking specific advice from your professional advisers.

1.6 How we are paid for services provided to retail clients

You will pay MAG the subscription fee annually in advance. An invoice will be issued to you and you must pay each invoice on the nominated date and into the nominated bank account detailed in the invoice by way of electronic funds transfer.

1.7 Professional Indemnity Insurance

We hold professional indemnity insurance, which provides cover for claims by retail clients that relate to the financial services that we provide.
